- If you have paid for the camp with a partial or full payment, then please attach a copy of the cancelled check or credit card receipt with the Campership Request form.
- **Send all of the above to Carole Poulin, Gateways Community Services, Nashua, NH 03064.**
- When all information is received and the Campership Committee has made a decision (usually about three weeks), you and the camp will receive notification from me of the campership award.
- **Last date to submit a 2010 Campership Request is September 30, 2010.**
- Any campership requests made after that date will be returned as denied by the Campership Committee.
