



## Scope of Services

### Facility Service Description

Gateways Adult Day Center (GADC) is a licensed adult day care provider located at the Wilbur H. Palmer Career and Technical Education Center, 200 Derry Road, Hudson, NH 03051. The program operates from 9:00 a.m. to 3:00 p.m. Monday through Friday, twelve months a year. The GADC is a highly valued program offering an innovative, intergenerational approach to geriatric and adult day care programming.

The GADC is a Medicaid approved facility. Dr. Lisa Scheib is the Medical Director. The GADC staff consists of a Manager, Administrative Assistant, Registered Nurse, Licensed Nursing Assistant, Activity Coordinator, and Activity Aides. The staff nurse administers medications and offers medical supervision to participants including monthly weight and vital sign assessments.

The GADC provides nursing support, therapeutic recreation, physical exercise, and nutritional guidance for 10-20 elderly and adult participants daily. Staff provides assistance with activities of daily living skills (ADL's) such as help with walking, toileting, eating, and removal/putting on or off coats. Structured Therapeutic activities are offered which provide stimulation and socialization. Lunch and afternoon snacks are served daily.

The GADC is not equipped to provide services for people who are who suffer from severe dementia (i.e., those who wander, or become combative or verbally abusive), and those with medical needs beyond the scope of our programming.

Transportation services are accessed through managed care companies or paid for privately.

The GADC currently has volunteers from the community, Alvirne High School, and various college interns.

The GADC policies and procedures are developed and implemented in accordance with the licensing requirements of the State of New Hampshire Department of Health and Human Services, Division of Public Health Services.
